### Views from the Gate

I am delighted to report that the behaviour of the gate this year has been substantially better than the cod fishing, which has been challenging to say the least. The expected bonanza following a very good year for cod fishing from the boats, some as close as a mile and a half from the Point and inshore boats in October just didn't materialise. Why? Well we really haven't had the SW winds this winter which dislodges the food and attracts cod to the beach, and the big storm at the end of October deposited literally tons and tons of shellfish and other marine life resulting in gorged fish and again difficult shore fishing. On the plus side, the October storm removed all the tackle snags which to date still haven't built up again to be a problem. This is the reason we haven't felt the need to commission a trawler to drag the beach again this year (yet!).

I've been called to the gate 3 times this year, once to replace a cut lock, the other two times to replace faulty locks. This is a massive reduction on the last few years and hopefully is a sign that anglers are starting to realise that the EA gate needs to be kept closed and undamaged otherwise the privilege of access can easily be lost.

Litter has again been an issue on occasion and I've even seen bags of litter left in the laybys where anglers park, often less than 10 yards from the nearest bin....and yes it was angling litter.



Unbelievable! The Dungeness estate is part of the National Nature Reserve. Part of your subs goes towards funding a paid litter picker however in this day and age, no litter at all is justifiable or defensible and this issue is a constant cause of embarrassment to the club and its members. If we all take home with us a little more than we brought, the litter problem would go away and the more of us that are seen collecting other peoples left litter the more a culture of respect will develop. Fortunately the littering anglers are a very small minority, but we all need to take care not to "lose" that worm paper under the shingle.

Well, that's it from the Gate, keep up the good work and tight lines for 2014.
